

Ashland Acquires the Assets of Nanjing Clear Environment Protection Co. Ltd. to Increase its Water Technologies Business in China

The company will manufacture products for water, wastewater and environmental protection, and also manufacture feed, control and monitoring equipment in Nanjing. These will be sold into all industrial, commercial and institutional markets in China. Programs will be used to treat cooling, boiler, wastewater, influent raw water, gas cleaning (air scrubbers), and other process applications in customer locations.
