\$10,000 Chairman's Award honors employee's volunteerism, aids fight against hunger

COVINGTON, Ky. – Ashland Inc. (NYSE: ASH) today announced that long-time employee Christi Clarke, a legal specialist in Russell, Ky., was named the 2011 recipient of the Chairman's Award for Community Enrichment. Despite their efforts, Clarke learned there were still a few children who would not be served, so she personally provided the additional support needed to ensure gifts for everyone.
